- Target Populations Identified by School Districts Most in Need of WIOA Services
 - Students with Disabilities
 - English Language Learners
 - Homeless or Runaway
 - Foster Youth

- Paid Work Experience
- Follow-Up Services After Graduation
- Leveraged Resources

Key Elements:

- A minimum of one project per geographic service delivery area.
- Each school district may apply for up to two projects
- Each project will serve 20 students
- School districts will not receive funding directly

- b. Linda Patino discussed on the California Workforce Association (CWA) Youth@Work Conference
 - i. Youth participant Daniela Paniagua was awarded a \$1,000 scholarship during the CWA Youth@Work Conference in January. She was one of nine deserving awardees selected from among numerous applications received from youth throughout California.
 - ii. WIB submitted and was approved to be a presenter at the CWA Youth@Work Conference. WIB, CSET, and SEE staff presented on the topic of “Strategies to create a multi-agency workforce partnership and a seamless referral process for youth who are justice involved and have disabilities”.
