e. <u>Accept Sumer Training and Employment Program for Students (STEPS) and Leading, Educating,</u> <u>Advocating, and Dedication (#LEAD) Funds to Operate Specialized Youth Workforce Programs for</u> <u>PY 2021-22</u>

WIB staff recommends:

- i. Accepting \$250,000 from the Foundation for California Community Colleges to continue the STEPS from July 1, 2021, through June 30, 2022, contingent upon receipt of funds.
- ii. Accepting \$50,000 from Tulare County Board of Supervisors to operate the Step Up #LEAD Youth Work Experience Program from July 1, 2021, through June 30, 2022, contingent upon Board of Supervisor's approval.
- f. <u>Accept Funds for Specialized Workforce Programs for PY 2021-22</u> WIB staff recommends:
 - i. Accepting \$2,000,000 from Tulare County Health and Human Services Agency to continue operating the Expanded Subsidized Employment Program contingent on receipt of funds from Tulare County Board of Supervisors. The term of the MOU is July 1, 2021, through June 30, 2022.
 - ii. Accepting \$239,847 from The City of Visalia to continue operating the Environmental Cleanup Opportunities Program contingent on receipt of funds. The term of the MOU is July 1, 2021, through June 30, 2022.
 - iii. Accepting \$139,160 from Tulare County Probation Department to continue operating the Readiness for Employment through Sustainable Education & Training (RESET) Program contingent on receipt of funds. The term of the MOU is July 1, 2021, through June 30, 2022.
 - iv. Accepting \$70,000 from the City of Tulare to continue operating the Community Development Block Grant Program contingent upon receipt. The term of the MOU is July 1, 2021, through June 30, 2022.
- g. <u>Approve Incumbent Worker Training Funding</u> WIB staff recommends authorizing the expenditure of up to \$50,000 on Incumbent Worker Training through June 30, 2022.
