- f. NNOVATORS By Design Facility Rental and Catering Accept Funds for Specialized Workforce Programs for PY 2022-23 to Implement the Summer Training and Employment Program for Students (STEPS), Leading, Education, Advocating and Dedication (#LEAD), and Readiness for Employment through Sustainable Education & Training (RESET) R2Y Youth Programs WIB staff recommends:
 - i. Accepting \$250,000 from Foundation for California Community Colleges (FCCC) to continue operating the Summer Training and Employment Program for Students (STEPS) contingent on receipt of funds. The term of the agreement is July 1, 2022, through June 30, 2023.
 - ii. Accepting \$100,000 from Tulare County Board of Supervisor to operate the Step UP #LEAD contingent on receipt of funds from July 1, 2022, through June 30, 2023.
 - iii. Accepting \$124,803 from Tulare County Probation Department to continue operating the Readiness for Employment through Sustainable Education & Training (RESET) R2Y for justice-involved youth contingent on receipt of funds. The term of the MOU is July 1, 2022, through June 30, 2023.
- g. <u>Accept Funds to Implement the Environmental Cleanup Opportunities Project, Expanded Subsidized Employment, and RESET Programs for PY 2022-2023</u>

WIB staff recommends:

- i. Accepting \$2,000,000 from Tulare County Health and Human Services Agency to continue operating the Expanded Subsidized Employment Program contingent on receipt of funds from Tulare County Board of Supervisors. The term of the MOU is July 1, 2022, through June 30, 2023.
- ii. Accepting \$221,847 from The City of Visalia to continue operating the Environmental Cleanup Opportunities Program contingent on receipt of funds. The term of the MOU is July 1, 2022, through June 30, 2023.
- iii. Accepting \$139,249 from Tulare County Probation Department to continue operating the Readiness for Employment through Sustainable Education & Training (RESET) Program contingent on receipt of funds. The term of the MOU is July 1, 2022, through June 30, 2023.

WIB staff recommends approving WIOA Adult, Dislocated Worker, and specialized workforce funds for PY 2022-2023 Title I Career Services Adult, Dislocated Worker services agreements upon receipt of funds for the following:

- i. Community Services Employment Training (CSET) for the Employment Connection Comprehensive Center in Visalia agreement #3702223 for up to \$2,334,898
- ii. Community Services Employment Training (CSET) for the Employment Connection Comprehensive Center in Porterville agreement #3682223 for up to \$1,611,121
- iii. Community Services Employment Training (CSET) for the Employment Connection affiliate site in Tulare agreement #3692223 for up to \$806,117
