- 2. Public Comment: Kerry Hydash Chair called for public comments; there were no public comments.

3. Consent Items:

- a. Approve November 18, 2020 Board Meeting Minutes
- b. <u>Approve WIB Employment Connection Committee Nominations</u>
 WIB staff recommends approval of the following nominations for the Employment Connection Committee: Joanna Schengel for College of the Sequoias, Darlene Tyndal for Tulare County Office of Education, and Dr. Michelle Miller-Galaz for Porterville College.

- a. Accept Funds from Tulare County Probation Department and Enter into an Agreement to Operate the Readiness for Employment through Sustainable Education & Training (RESET R2Y) Program Staff recommends that the WIB:
 - i. Accept funds and enter into an agreement with Tulare County Probation Department to implement the Readiness for Employment through Sustainable Education & Training RESET R2Y Program in the amount of \$186,453, retroactive to January 1, 2021 through June 30, 2022. Find that the WIB had authority to enter into the proposed agreement as of January 1, 2021 and that it was in the WIB's best interest to enter into the agreement on that date.

Modify the PY 2020-21 WIOA Youth Service Provider agreement with CSET #2481920 by allocating an additional \$32,236, contingent upon receipt of funds, for the R2Y program retroactive to January 1, 2021 through June 30, 2021. Find that the WIB had authority to amend the agreement as of January 1, 2021 and that it was in the WIB's best interest to amend the agreement on that date.
- iii. Modify the PY 2020-21 WIOA Youth Service Provider agreement with TCOE #2631920 by allocating an additional \$29,414 contingent upon receipt of funds for the R2Y program retroactive to January 1, 2021 through June 30, 2021. Find that the WIB had authority to amend the agreement as of January 1, 2021 and that it was in the WIB's best interest to amend the agreement on that date.

Motion by Harroll Wiley, second by Yolanda Valdez to accept funds from Tulare County Probation Department and enter into an Agreement to operate the RESET R2Y program; carried by unanimous vote.
