- 1. Call to Order: Kerry Hydash Chair called the meeting to order at 7:30 a.m.
- 2. Public Comments: Kerry Hydash Chair called for public comments; there were no public comments.

# 3. Consent Item:

- a. Approve April 8, 2020 Board Meeting Minutes
- b. Accept Expanded Subsidized Employment (ESE) funding from Tulare County Health & Human Services Agency (HHSA)
  - WIB staff recommends accepting HHSA ESE funding in the amount of \$2,000,000 to implement the Expanded Subsidized Employment program for a seventh year, contingent upon receipt of funds.
- c. <u>Accept funds from Tulare County Probation Department to Operate the Readiness for Employment through Sustainable Education & Training (RESET) Program in PY 2020-2021</u>
  - WIB staff recommends accepting \$137,981 from Tulare County Probation Department to continue operating the RESET Program for the sixth year, contingent upon receipt of funds. The term of the MOU is July 1, 2020 through June 30, 2021.

- II. Enter into an agreement in the amount \$32,734 with CSET to operate the STEPS program within in Visalia and Tulare areas contingent upon receipt of funds.
- III. Enter into an agreement in the amount of \$33,366 with TCOE to operate the STEPS program within the Porterville and surrounding areas, contingent upon receipt of funds.
